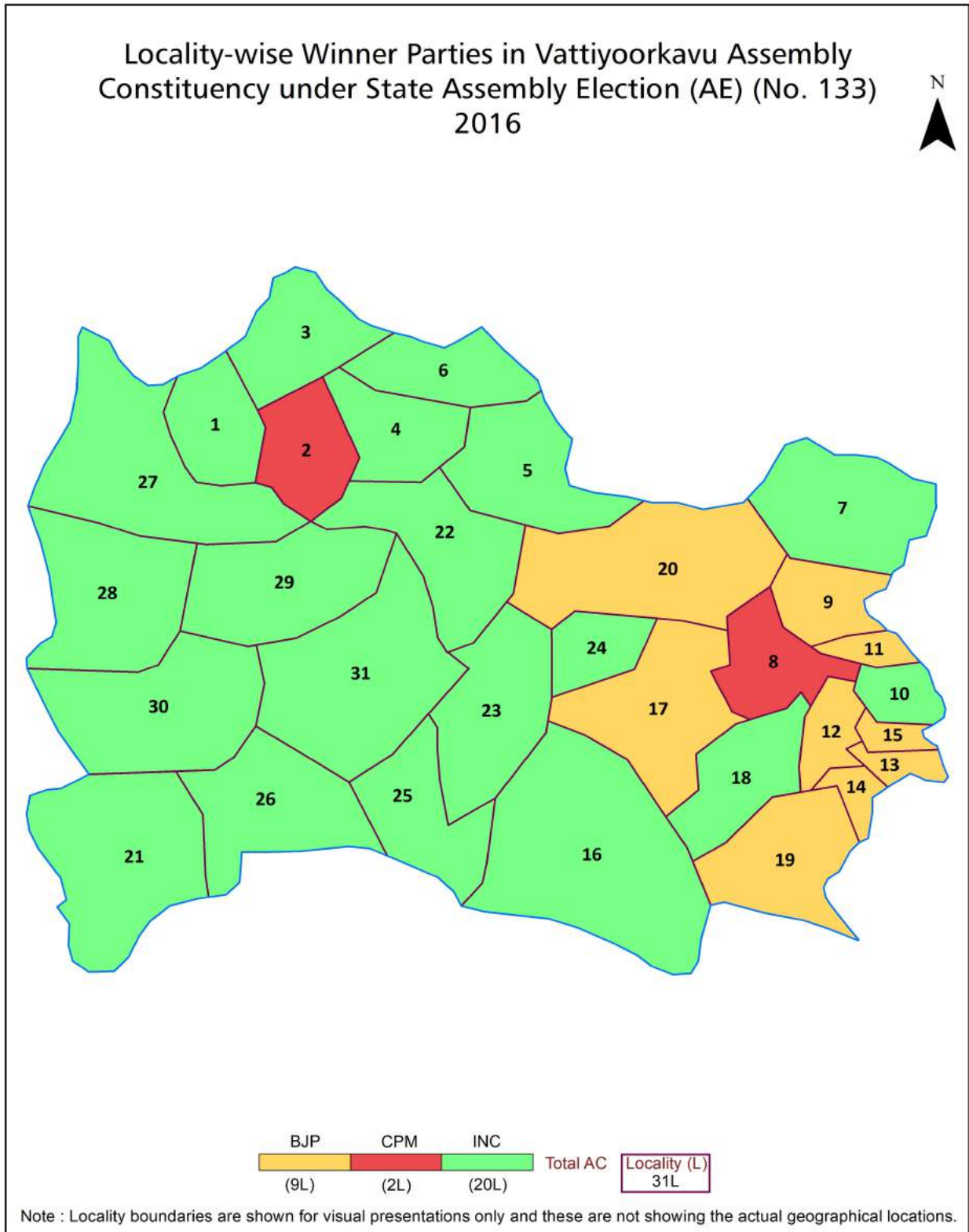

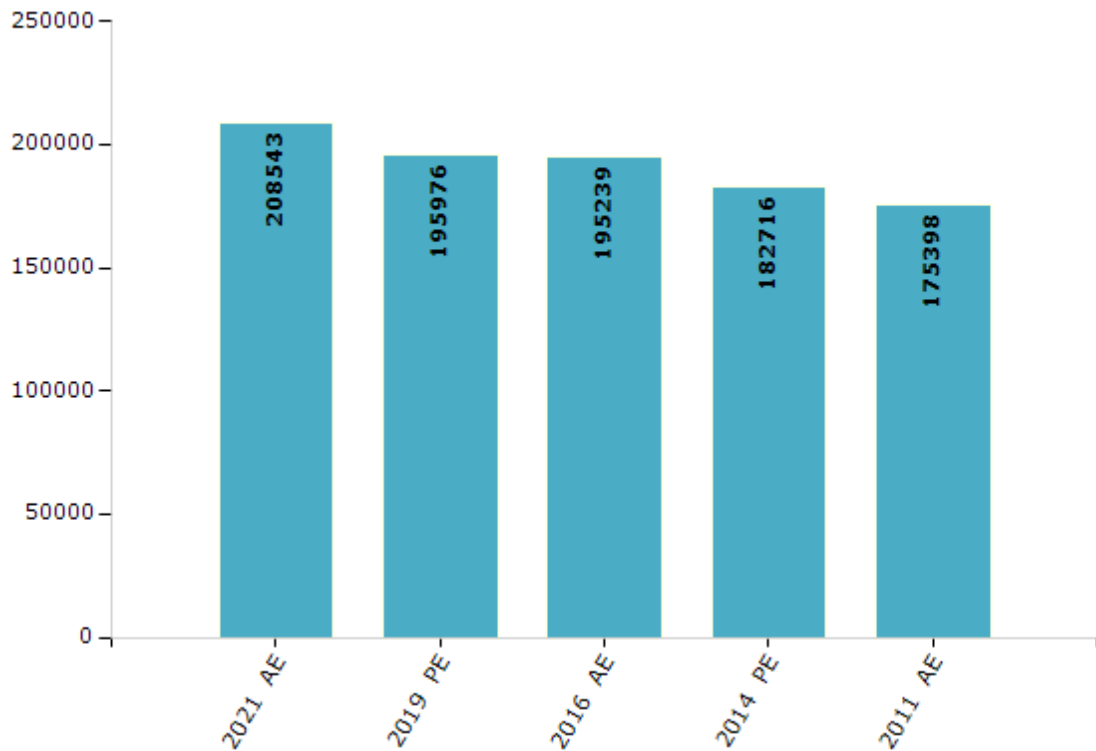

Number of Electors



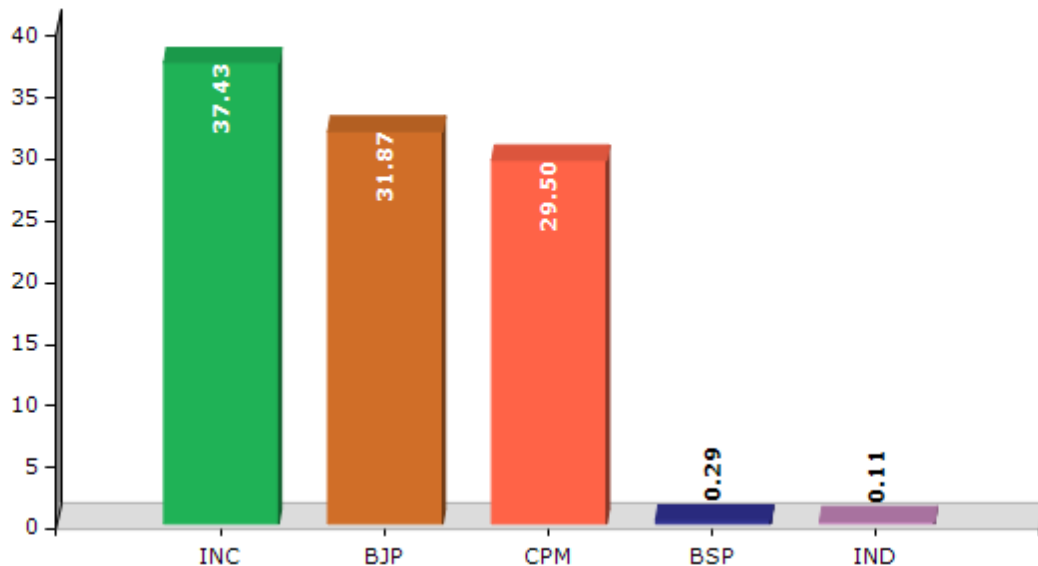
